These are the Official Rules of the Ohio Golden Owl Award® Contest ("Contest"). ### **ELIGIBILITY**

Nominees must be Ohio-licensed educators currently teaching agricultural education courses at the secondary (middle/high school) level. **No purchase is necessary**.

Nominations can be submitted by the general public, current or former students, parents, fellow educators, school administrators and community members.

Employees, affiliates, subsidiaries, advertising and promotion agencies, and any entity involved in the development, production, implementation, administration or fulfillment of the Contest (all of the foregoing, together with Nationwide, OH FFA, Farm Credit, and OFBF collectively referred to as "Promotion Entities") are not eligible to enter the Contest. ## **HOW TO ENTER**

The Nomination period begins September 1, 2025 and ends December 31, 2025 at 11:59 p.m. EST ("Nomination Period").

To enter, provide your and the ag teacher's contact information, including an essay (250 words or less) describing how the teacher's dedication to agriculture education, and commitment and impact on today's youth make the teacher the best in the state.

Entry constitutes consent to participate in the Contest and for the OH FFA to obtain, use, and transfer the entrant's name, address and other details for Contest administration purposes. OH FFA will not be responsible for lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries; technical or mechanical malfunctions; errors in the Official Rules, in any related ads or materials; or processing error. OH FFA can void the entry of any Entrant who it believes has attempted to tamper with or impair Contest administration, security, fairness, or proper play.

### HONOREE DETERMINATION

Ten (10) Honorees will be selected by an established committee

An established committee will evaluate nominations received and select (1) one Honoree from each of Ohio FFA's (10) ten districts.

Nominations will be judged based on the following criteria:

- 1. Teacher's dedication to agriculture education
- 2. Teacher's commitment to his/her student(s)
- 3. Teacher's impact on his/her student(s)
- 4. Teacher's impact on their local community
- 5. Number of nominations for the teacher

In the event of a tie, the teacher receiving the highest number of nominations shall be selected as Honoree, as determined by the selection committee.

Honorees will be notified no later than March 13, 2026.

### **GRAND PRIZE WINNER DETERMINATION**

Each of ten (10) Honorees will be required to compete a short form to finalize their application for the Overall State winner. The completed form is due no later than March 20, 2026.

Ahead of the 2026 Ohio FFA State Convention, the committee will review forms submitted. The committee will deliberate and make their final selection for the Ohio Agricultural Educator of the Year.

During the 2026 Ohio FFA State Convention, the new Ohio Agricultural Educator of the Year will be announced.

If a Prize winner is not eligible to win, or if OH FFA is unable to contact the winner after a reasonable effort, the prize will be forfeited, and an alternate winner may be selected. Odds of winning depend on number of eligible entries received.

# SPONSORS ARE NOT RESPONSIBLE FOR TRAVEL-RELATED EXPENSES ASSOCIATED WITH PRIZE ACCEPTANCE.

## **PRIZES**

Prizes will be awarded as follows:

- 1. One (1) Grand Prize Winner: Trophy and a \$5,000 cash prize
- 2. Ten (10) Honorees: Plaque and a \$1,500 cash prize to honoree
- 3. All nominees: Paper certificate
