The Chapter Trust Fund Program offers an opportunity for each chapter to make a long-term investment to support FFA member awards, scholarships, and leadership activities for years to come.



Your chapter can celebrate the FFA centennial by helping secure the next 100 years of Ohio FFA through endowment donations! Join the challenge of 100 chapter trusts either opened or completed by spring 2029.



Fund the next generation of leaders as your chapter commits to contributing \$1,000 – paid over four years in \$250 installments. Chapters may also increase yearly contributions to establish the trust sooner.

Submit your commitment form to the Ohio FFA Foundation to begin establishing the trust in your chapter's name. Your chapter commitment form and a payment of at least \$250 is due to the Ohio FFA Foundation by March 15 in order to be recognized at the Ohio FFA Convention.



Your chapter will be recognized on stage during the Ohio FFA Convention. With your commitment to contribute to the Chapter Trust Fund program by March 15, your chapter will receive a certificate each year until the \$1,000 trust is established. The final year, your chapter will receive a plaque to recognize your promise to future Ohio FFA members.

Once the permanent trust is established, your chapter will be listed in the convention program and Ohio FFA annual report each year.
